

**Application for Orleans Snowstormers Membership and TMA:
What you need to send to buy your TMA:**

Resident TMA: You must live in Vermont and have a Vermont Snowmobile Registration. You MUST SEND a copy of your 2010 Vermont Snowmobile Registration and a check or money order with completed application.

Non- Resident Vermont Taxpayer Resident TMA: A Non- Resident who owns property and pays Vermont Property Tax in Vermont with a Vermont Snowmobile Registration can purchase a Resident TMA. You MUST SEND a copy of current Vermont Tax Bill and your 2010 Vermont Snowmobile Registration and a check or money order with completed application.

Non-Resident TMA: Any Non- Resident or Vermont Resident with a Snowmobile Registered in another State or Canadian Providence. You MUST SEND a copy of your 2010 Snowmobile Registration and a check or money order with completed application.

*******EARLY BIRD DISCOUNT: To qualify for the Early Bird Discount you MUST PURCHASE your TMA through December 15TH. All mailed in applications MUST be dated and post marked no later than December 15TH.**

FEES: ALL FEES include a \$10.00 Club Dues and a \$1.00 County Dues

Classic TMA:

Snowmobile must be 15 years or older < Model year 1995 or older >

Resident and Non- Resident \$81.00
Early Bird \$61.00

Family Rate TMA:

(All Snowmobiles must be Registered to the same person) The first two snowmobiles Registered to the same owner(S) with the same mailing address will pay the regular rate and any additional snowmobiles will pay the 1/2 price for each over the first two:

Resident: \$101.00 (First Two) each
Additional Sled: \$ 56.00 each
Early Bird: \$76.00 (First Two) each
Additional Sled: \$ 44.00 each

Non – Resident: \$141.00 (First Two) each
Additional Sled: \$76.00 each
Early Bird: \$106.00 (First Two) each
Additional Sled: \$59.00 each

5 DAY PASS:

The Five day Pass will not include the Liability Insurance and will be available after Dec. 15TH the price is \$75.00 each:

*** As of September 01, 2003, every individual operating a snowmobile in Vermont is required to have Personal Liability Insurance. The minimum required coverage is \$25,000 for one injury or \$50,000 for two or more injuries or deaths with a minimum of \$10,000 property damage.***

(The fine for operating without the insurance is \$600.00 plus court cost) NO proof of insurance required to buy your TMA:
